Karen and Richard Light truly illuminated our lives by their example and passion for the natural environment. Richard was a self-taught naturalist who enjoyed sharing his knowledge of the flora and fauna, particularly found in the Swatara State Park. He taught others through his slide shows, field trips, and WLBR's Talk Show. For many years Richard could be found checking his 60 bluebird boxes at Greater Lebanon Refuse Authority.

Karen R. Light was a beloved teacher, principal, and friend. In her quiet, unassuming way she also enjoyed sharing her love of the natural world with others. To Karen and her husband Richard H. Light, everything in the natural world was important and worthy of respect. Karen deeply felt that she needed to be an advocate for those little creatures that don't have a voice. From a Spotted Salamander to a Saw-whet Owl to a Yellow Lady Slipper, all were appreciated and studied. The Lights' home was tucked into the side of the mountain near Swatara State Park, putting all of nature on display. Richard would take long walks in the park and then take Karen to witness his discoveries. His advice to all when walking in the woods was to take two steps, and then stand five minutes to observe nature. Visit Swatara State Park, sit on their Memorial Benches by the AT Bridge and enjoy nature.

Richard and Karen Light were active members of Quittapahilla Audubon Society, Lancaster Bird Club, Entomology Club, Muhlenberg Botanical Society, Lancaster Herpetology Club, Monroe Valley Chapel, and Historic Preservation Trust, The Lebanon Valley Conservancy, Manada Conservancy, and Friends of Memorial Lake & Swatara State Park. They were loyal volunteers with the Ned Smith Center's saw-whet owl research project

Richard H. Light passed away in April 2016 and Karen R. (Geesey) Light passed away in April 2018. Their hearts and passions revolved around conservation and inspiring others to preserve this beautiful earth. To this end, the recipients of The Richard H. and Karen R. 5. Reflect on the environmental legacy of Karen and Richard Light and consider how you will continue this environmental advocacy in your personal life, educational pursuits, and career.

## FREQUENTLY ASKED QUESTIONS

### 1. What are the eligibility requirements for this scholarship?

- a. The applicant needs to be a graduating high school student who is a resident of the Lebanon Valley or a college student at Lebanon Valley College or Harrisburg Area Community College.
- b. The scholarship applicant must plan to study within the chosen fields of conservation, ecology, natural resources/wildlife management, water resources and management, or environmental sciences.

### 2. What is the scholarship value?

The scholarship is \$2500.

### 3. When will I know if I am awarded this scholarship?

If your school has an awards ceremony, you will receive a certificate at that time. Additionally, your school counseling office will be notified before your graduation date or The Lebanon Valley Conservancy will notify you.

A representative of the Conservancy will notify each applicant either by mail, email, or phone call whether they are selected or not for the award.

### 4. If I am awarded this scholarship, when will I receive the money?

The Lebanon Valley Conservancy will distribute the funds at a Spring Event or the May 2022 Board Meeting.

### 5. Are there any other requirements?

TLVC requests that within one year of receipt of the scholarship, the recipient sends a letter updating TLVC on any progress in your coursework or in your chosen field.
